#### 1. Call to Order and Roll Call

# 2. Approval of Agenda

Director Ropp moved, and Director Babut seconded to approve the agenda as presented. Unanimously approved.

#### 3. Co-owner Comments

Co-Owner Jason Yunk was present.

### 4. Approval of Minutes of Preceding Meeting

Director Sielaff moved, and Director Ropp seconded to approve the minutes of the November 15, 2021 board meeting as presented. Unanimously approved.

### 5. Review of Preceding Month Financial Reports

Director Ropp provided an overview of the December and annual operating results, highlighting expense variances and month-end fund balances. Director Babut moved, and Director Ropp seconded to accept the financial reports as presented. Unanimously approved.

Director Babut provided an overview of recently approved requests for authorization to make modifications to the exterior of CHV I homes, the most recent being the installation of a pool. Ms. Babut stated that 51 requests had been processed in 2021.

Jeff McDuff and Dan Herriman reported on the status of current financial, administrative and maintenance matters. Mr. McDuff reported that CHV II's fire suppression contractor will be eliminating the existing Glycol product and replacing it with an upgraded product, to meet new regulatory requirements, as repairs are made. Mr. McDuff was authorized to proceed to contract the current recommended scope of work.

  Management will request an update on the status of this matter, from the Association's law firm.
- 8.2 CHV II Progress Report on Future Use of Two Vacant Lots
  Director Ropp moved, and Director Sielaff seconded to accept the initial draft plans created by the engineering firm (Nowak & Fraus) engaged by the Association, with the following stipulations:
  - 1. For the Filmore Street lot: "Flip" the active and passive sides of the 2 Site Condos,
  - 2. For the 4-plex on the other lot: Ensure known constructions issues are not repeated. Unanimously approved.
- 8.3 CHV II Progress Report on Improvements to Cease Encroachment by CHV II Lot 101 upon CHV I Lot 102
  - Jeff McDuff reported that the proposed plan created by Midwest Consulting was approved by the Canton Township Planning Department. The project will now go out for bid.
